A New Strategic Plan

In January 2007, the CPHA Board of Directors approved a new strategic plan to guide the organization for the next decade. The plan addresses the Association's need to choose wisely the range of activities we undertake in order to maximize our impact on public health in Canada and around the world. The plan focuses on three desired outcomes:

- ✦ mobilization of stakeholders across the continuum in support of public health;
- ✦ development and implementation of effective public health policy through an efficient public health structure at each level of government; and
- ✦ a public health system that is supported by a sufficient number of appropriately skilled practitioners.

Moving from Strategy to Action

In order to achieve these outcomes, CPHA is focusing on five important objectives:

- ✦ transforming CPHA into a financially resilient organization;
- ✦ strengthening CPHA's collaborative relationships;
- ✦ mobilizing stakeholders;
- ✦ enhancing capacity in the public health sector; and
- ✦ focusing on advocacy.

action

Though the plan is only in its first year of implementation, significant progress has already been made.

Financial Stability and Growth

CPHA continues to undertake important public health programming with funding from government partners. This programming remains a key strength of CPHA. Recent unanticipated program cuts and closures, however, reinforced the need for organizational transformation to ensure CPHA's continued financial stability and growth.

In 2007, the process of transformation began. The findings of a preliminary review of CPHA's revenue-generating activities indicate that there are opportunities to increase our revenue in a number of areas. A compelling Case for Support that tells the story of CPHA and public health was developed and will be used as an important tool to support revenue development and corporate partnerships.



CPHA also began the expansion of its corporate partnership program. A joint initiative with Reckitt Benckiser, CPHA's first major corporate partner, resulted in the launch of the Infectious Diseases Portal, a website that facilitates the dissemination of resources that support the prevention of infectious diseases for both health professionals and the general public. We will continue to explore and expand our relationships with corporations and foundations who share our values.

Collaborative Relationships

Through the dedication of its members, CPHA continues to be represented on numerous external committees, task forces and at meetings that help shape the future of Canada's health system. The sheer volume of these requests for representation created the need to develop a process to guide the selection of collaborative relationships to maximize our impact on the Association's priority policy areas. In 2007, this selection process was developed, and new collaboration requests will begin to be assessed on criteria that include:

- ✦ alignment with CPHA strategic priorities;
- ✦ public health relevance;
- ✦ potential impact; and
- ✦ resource implications.

At the national level, CPHA continues to take a leadership role in the Canadian Coalition for Public Health in the 21st Century. The Coalition is a pan-Canadian network of both non-profit and professional organizations, health charities and academic research organizations that advocate for adequate public health functions to protect and promote health and prevent disease and injury in Canada. The Coalition has developed clear priorities for building public health capacity and leadership in Canada as well as an advocacy plan in the event of a federal election.

Through new and ongoing global public health initiatives, CPHA is strengthening its international relationships and continues to help build the organizational capacity of the World Federation of Public Health Associations (WFPHA). The *Strengthening of Public Health Associations (SOPHA)* program continues to help build public health association capacity in countries around the world. SOPHA has participated in the revitalization of the East, Central and Southern Africa Public Health Association (ECSAPHA) and the establishment of the Réseau des Associations de santé publique en Afrique francophone (RASPAF). The *Canadian International Immunization Initiative (CIII-2)* provided technical assistance in 13 developing countries through the deployment of 35 Canadian consultants.

Collaboration continues to be at the heart of CPHA's Annual Conference, providing a unique opportunity for joint leadership of the only national public health conference.

The rebranding exercise also included a complete redesign of our website, resulting in a more user-friendly web presence for the Association. 


CPHA continues to act as the secretariat for the *Canadian Coalition for Immunization Awareness & Promotion (CCIAP)*, a partnership of national non-governmental, professional, health, consumer, government and private sector organizations interested in promoting the understanding and use of vaccines. Through education, promotion, advocacy and media relations, CCIAP contributes to the elimination of vaccine-preventable diseases in Canada. CCIAP's achievements in 2007 included:

- ✦ National Immunization Awareness Week, coordinated across Canada in April;
- ✦ a fall Influenza Immunization Awareness campaign;
- ✦ expansion of the online information centre for immunization at immunize.cpha.ca;
- ✦ an increase in adult immunization promotion through ads in consumer and professional publications; and
- ✦ Canada-wide distribution of a new adult immunization record.



public education



In March 2007, CPHA published *Turning Points: Twenty-five Years of HIV Prevention in Canada*, which provides an overview of the history of HIV prevention in Canada, highlighting the evolution of national, regional and local prevention activities. The report considered the different approaches taken in Canada since the beginning of the epidemic in 1982 and identified challenges to be addressed by future efforts.

Enhancing Public Health Sector Capacity


CPHA's project work continues to expand the knowledge, skills and practice of public health professionals across the country. Through continuing education, supporting the creation of networks and sharing tools for professionals, CPHA strives to enhance capacity in the public health sector.

- ✦ In partnership with the *National Specialty Society for Community Medicine (NSSCM)*, CPHA supported the development and use of training tools for the continuing education of community medicine specialists and public health physicians.
- ✦ Working on behalf of the Public Health Agency of Canada, CPHA is helping to pioneer the development of the *Early Detection and Response Course for Health Professionals in Canada*, an accredited course for front-line clinicians to increase Canada's capacity to detect, report and contain emerging and re-emerging infectious diseases of public health significance.
- ✦ The *Strengthening Chronic Disease Prevention and Management* project has been working with key stakeholders to assess current practices in chronic disease prevention and management and has helped define the role for public health in chronic disease prevention and management initiatives.
- ✦ The *Pandemic Health Alert Network (PHAN)* brought together a diverse group of organizations such as the Canadian Council of Grocery Distributors, the Canadian Labour Congress and the Federation of Canadian Municipalities to help individuals and organizations "prevent, prepare and protect" in the event of an influenza pandemic.
- ✦ CPHA's Board established the Global Health Advisory Committee to advise CPHA on the orientation of its Global Health Program. The committee's report, *A Public Health Approach for Global Development: CPHA's Global Public Health Strategy 2007-2017* was endorsed by CPHA's Board of Directors in February 2008.



building capacity

- ✦ The *Building Civil Society's Voice for Public Health in the Balkans* has seen the establishment of a new public health association in Bosnia & Herzegovina, the first civil society organization representing public health in that country.
- ✦ Through the *Intersectoral Action for Health (Brazil)* initiative, CPHA and its Brazilian partners have worked with six municipalities to establish a variety of health promotion interventions and local capacity-building activities.
- ✦ 2007-2008 marked the final phase of CPHA's direct involvement in the management of the *Southern African AIDS Training Programme*. CPHA has continued to provide technical assistance and financial support to the Southern African AIDS Trust (SAT), the independent non-governmental regional organization that is now responsible for the implementation of the project.
- ✦ The January 2008 *Health Literacy Symposium* engaged leaders in health and public health to help develop a pan-Canadian health literacy strategy based on the findings of our Expert Panel on Health Literacy.


Focus on Advocacy

As the authoritative non-governmental voice of public health in Canada, CPHA continues to influence the development of public health policy at the federal level. A review of CPHA's policy development process has resulted in the Board beginning to create a more proactive approach to policy development and advocacy. This new approach is designed to enhance the involvement of members, CPHA's Advisory Council and, in the future, issue-specific expert working groups.

As an initial step, CPHA's Advisory Council conducted an environmental scan to identify the most important public health issues and areas where CPHA can best take a leadership role. In early 2008, the CPHA Board of Directors contacted members to seek their input on the Association's priority-setting exercise. The results will guide us as CPHA further develops its advocacy efforts.

CPHA Publication Sales



Plain Language Service


