## **Assistant Professor or Associate Professor, Tenure Track Faculty Position**

This position is part of a multi-year interdisciplinary initiative designed to strengthen and support research innovation and excellence in the domains of African and Black Studies at McGill University while simultaneously addressing the under-representation of Black faculty in the tenure stream, as laid out in [McGill's Action Plan to Address Anti-Black Racism 2020-2025 \(ABRp\)](#).

### **Position Description:**

The Ingram School of Nursing of the Faculty of Medicine and Health Sciences is seeking applications for a tenure-track position in the area of access to quality health care by racialized and other marginalized populations, potentially including innovative approaches to care delivery (e.g., telehealth, use of mobile apps). This tenure-track position is open for appointment at the rank of Assistant or Associate Professor.

The successful candidate will be joining the School at a stimulating time of growth and new energy with a recent expansion in education and research-focused faculty, major curricular revisions, and a new physical space featuring state-of-the-art teaching and research facilities.

The School is part of McGill University, which is consistently ranked among the top 20 public universities in the world and among the top three in Canada. ### **Job Duties:**

The successful candidate will be expected to develop an independent research program and to contribute to undergraduate and graduate teaching for our diverse student body. They will also be expected to contribute to service activities within the School, the Faculty of Medicine and Health Sciences, the University, or the wider community.

## **Qualifications and Education Requirements:**

- Candidates will have been educated as nurses or have a research focus relevant to nursing, have a doctorate in a health-related discipline and a track record of peer-reviewed publications.
- Post-doctoral training will be an asset, as will evidence of success in receiving competitive, external research funding.
- Promising candidates who would benefit from additional post-doctoral training may exceptionally be considered for a transitional fellowship in preparation for moving into this tenure-track position.
- Candidates must demonstrate a commitment to and in accordance with circumstances, a track record in equity, diversity, and inclusiveness (EDI) in such contexts.
- In response to commitments made in McGill's Anti-Black Racism Action Plan, among otherwise equivalent candidates, preference will be given to Black scholars.
- Candidates should be fluent in English; fluency in French would be an asset.
