The successful candidate must be registered and in good standing with the College of Physicians and Surgeons of Ontario and possess one of the following: fellowship in community medicine from The Royal College of Physicians and Surgeons of Ontario, or; a certificate, diploma or Master's degree from a university recognised in Canada that is granted after not less than one academic year of full-time post-graduate studies or its equivalent in public health, comprising, (i) epidemiology, (ii) quantitative methods, (iii) management and administration, and (iv) disease prevention and health promotion; or recognition from the College of Physicians and Surgeons of Ontario to practice as a MOH in Ontario. The preferred candidate should have at least five years in the practice of medicine, with at least three years spent in an administrative or managerial position within a public health department or agency. French language skills would be an asset.
